



Glacier Hills Weekend Package

New Weekend Package Available May - October

Please read the following information in it's entirety before proceeding with your reservation.

- 1) **Begin by selecting your dates – The dates for the Weekend Package must begin on a Friday and end on a Sunday.**
- 2) **3-day Minimum is required during Peak Season.**
- 3) **Peak Season is May – October.**
- 4) **You may have the Hall until Midnight at no extra cost***

If you are reserving the Glacier Hills Hall & Chapel Weekend Package (Friday-Saturday-Sunday) you must book at least a 3 day minimum stay during the Peak Season.

Glacier Hills Hall and Chapel are also available to rent as a 1-day rental during Peak Season (Monday – Thursday). If you would like to reserve the Hall and Chapel during the non-Peak Season you must reserve each separately.

**Weekend package fee includes the Hall and Chapel from Friday at 12:00 pm thru Sunday at 5:00 pm. The Hall and Chapel are not available for single weekend day rentals from May-October.*

Notice of Cancellation. For reservations listed above excluding the 3-day rental package - notice of cancellation must be given to the Planning & Parks Department **90 days** prior to the reservation date in order to receive a full refund minus a **\$100.00** administrative fee. Reservations cancelled less than **45 days** prior to the reservation date will receive a **50% refund minus a \$100.00** administrative fee. Reservations cancelled less than **30 days** prior to the reservation date will receive a refund on the damage deposit only.

***Effective March 1, 2018 for the 3 Day Rental 'Weekend Package' at Glacier Hills County Park from May 1 – October 31 – Peak Season.** Notice of Cancellation must be given to the Planning and Parks Department **180 days** prior to the reservation date in order to receive a full refund minus a **\$200.00** administrative fee. Reservations cancelled less than **180 days** prior to the reservation date will receive a **50% refund minus a \$200.00** administrative fee. Reservations cancelled less than **90 days** prior to the reservation date will receive a refund on the damage deposit only.

Damage Deposit Fees: Damage deposits will be returned in accordance with current Washington County accounting procedures unless physical damage, excessive litter, or conduct which violates various Federal, State, County or local regulations occurs in connection with said reserved activity. Damage in excess of a deposit shall be borne by the person signing the application. Misrepresentation on the application will result in forfeit of damage deposit and immediate ejection from the park. Deposits will be refunded to the person signing the reservation application form by mail approximately **three (3) weeks** following the reservation date, when the staff certifies that no physical change to the facilities took place and the facilities were properly cleaned up immediately following the reservation. Cleaning equipment or supplies are not furnished by the department.

Frequently Asked Questions...

Yes, you may choose your own catering vendor and your own bartender for your special event. Compliance with all local, County, State and Federal regulations must be adhered to when serving alcoholic beverages.

Notice of Cancellation. For reservations **listed above** excluding the 3-day rental package - notice of cancellation must be given to the Planning & Parks Department **90 days** prior to the reservation date in order to receive a full refund minus a **\$100.00** administrative fee. Reservations cancelled less than **45 days** prior to the reservation date will receive a **50% refund minus a \$100.00** administrative fee. Reservations cancelled less than **30 days** prior to the reservation date will receive a refund on the damage deposit only.

***Effective March 1, 2018 for the 3 Day Rental 'Weekend Package' at Glacier Hills County Park from May 1 – October 31 – Peak Season,** Notice of Cancellation must be given to the Planning and Parks Department **180 days** prior to the reservation date in order to receive a full refund minus a **\$200.00** administrative fee. Reservations cancelled less than **180 days** prior to the reservation date will receive a **50% refund minus a \$200.00** administrative fee. Reservations cancelled less than **90 days** prior to the reservation date will receive a refund on the damage deposit only.

Portable music and sound equipment may only be used in the park in such a manner which is not a nuisance to other users or park personnel this includes live amplified music or amplified musical instrument playing.

Before your security deposit/damage deposit fees will be reimbursed to you in the form of a check – mailed to you at the address indicated on your reservation you will need to clean-up. Damage deposits will be returned in accordance with the current Washington County accounting procedures unless physical damage, excessive litter, or conduct which violates various Federal, State, County or local regulations occurs in connection with the said reserved activity. Damage in excess of the deposit shall be borne by the said person responsible for the reservation. Deposits will be returned by mail approximately 3 weeks following the reservation date, when staff certifies that no physical change to the facilities took place and the facilities were properly cleaned up upon your departure.

Clean-Up information

All groups must complete the following in order to receive full damage deposit:

- All garbage must be emptied in the dumpster provided in the lower parking lot or in the dumpster in the upper area.
- Floors must be swept and mopped if needed (use warm water only to mop floors).
- All tables, chairs, kitchen counters, and sinks must be cleaned, if used.
- All tables and chairs must be stacked appropriately on carts provided and returned to kitchen area.
- Turn off lights and close all windows. Turn off ceiling fans and exhaust systems.
- All decorations must be taken off the walls and ceilings, including any adhesive used.
- Balloons are not allowed.
- Asphalt area near Glacier Hills Hall (GH1) must be litter free and all picnic tables put back.
- Cooler must be completely emptied.
- Designated tables are labeled "FOR SERVING ONLY" – should be used for hot foods Nescos, etc.
- Turn down heat to 50°.
- The building is expected to be as clean when you leave as when you entered and you must be out at the time indicated on your reservation.
